SECTION II

TERMS and CONDITIONS

1. License; Authorized Site and Users

Begell House, Inc., grants the Subscriber a nonexclusive, non-transferable, revocable right and license to access and use, and to permit Authorized Users to access and use, the Begell Digital Library online service and, from such service, to access and use the Online Journal(s) for which the Subscriber maintains a subscription (as indicated in Section I of this License), provided always that such access and use is made through a secure network under the Subscriber's control located at the Subscriber's Authorized Site, all subject to the terms and conditions described in this Agreement. Begell House, Inc. shall not be required to distribute, and the Subscriber shall not redistribute, the Begell Digital Library online service or any Online Journal to a country where the export thereof is prohibited by U.S. law or regulation.

This License is granted for the personal, non-commercial use of the Subscriber and Authorized Users for purposes of research, teaching and private study. The number of Authorized Users who may access the full text of the subscribed Online Journals at any given time is unlimited. The Begell Digital Library online service includes the Online Journals and any additional features that Begell House, Inc. may choose to provide from time to time, any restrictions on use apply to all online materials accessed under this License.

The Subscribing Institution and Authorized Users may only use this online access in a way that conforms to all applicable laws and regulations. 3. Prohibited Uses

The Subscriber shall not, and shall not permit Authorized Users to:

Unless terminated sooner for cause in accordance with subparagraphs b and c below, this License will remain in effect with respect to each Online Journal while the Subscriber maintains a current paid subscription for online access or which includes online access to that Online Journal, and the License shall renew automatically for the term of any renewal subscription to that Online Journal upon receipt by Begell House of payment for that renewal subscription. This License will terminate with respect to each Online Journal when the Subscriber's paid subscription to that Online Journal lapses, and in such event the effective date of termination of this License with respect to that Online Journal shall be the last day of the paid subscription period. - b.
